**Liability Waiver / Hold Harmless Agreement
and Photograph Release Form**

There are inherent risks in participating in any recreational activity including fishing. All participants either as an attendee or spectator have a duty to exercise good judgment and act in a responsible manner while partaking in this event.

To the best of my knowledge, I am in good physical condition and believe myself fully medically able to participate in the fishing derby event. I am fully aware of the risks and hazards connected with the participation in this fishing derby, including physical injury or even death, and hereby elect to voluntarily participate in said activity, knowing that the associated physical activity may be hazardous to me and my property. **I voluntarily assume full responsibility for any risk or loss, property damage, or personal injury, including death that may be sustained by me, or loss or damage to property owned by me, as a result of participation in these activities.**

I hereby **release, waive, discharge, and covenant not to sue**, the North Branch Trout Derby Association and any landowners who have given their permission to access their property, servants, contractors, agents, volunteers and sponsors (hereinafter referred to as **Releasees**) from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or to any property belonging to me, while participating in the trout fishing derby or while upon the premises where such activities are being conducted.

It is my expressed intent that this release and hold harmless agreement shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a **release, waive, discharge, and covenant not to sue** the North Branch Trout Derby Association, its officers, board members, volunteers and or property owners for which the event is being held. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be constructed in accordance with the laws of the Commonwealth of Pennsylvania.

I hereby grant North Branch Trout Derby Association to use my likeness in photograph(s)/video in any and all of its publications and in any and all other media, whether now known or hereafter existing, controlled by North Branch Trout Derby Association, in perpetuity, and for other use by the Association. I will make no monetary or other claim against North Branch Trout Derby Association for the use of the photograph(s)/video.

In signing this release, I acknowledge and represent that **I have read the forgoing Waiver of Liability and Hold Harmless Agreement, Understand it and sign it voluntarily** as my own free act and deed; no oral representations, statements or inducements, apart from the foregoing written agreements have been made; and **I execute this release in full, adequate and complete consideration fully intending to be bound by same.**
